3: Matters arising from the minutes:

5: Roads Report: Veronica notified the City Roads dept. 1st. thing Monday morning about the downed sign post at Pirates Lane & Colvilleton Trail. It is scheduled for repair and resurrection sometime within the week.

6: Parks Committee Report. The joint PINA/Lions Open House with Parks manager Al Britton re: the 2019 upgrade to the stairs to Pirates Park was held Nov. 21st. The well received input from islanders will be incorporated into the design. Photos of the proposed metal grating treads currently used in parks in town were circulated. A 2nd. meeting will be held sometime in Feb. to go over the final plan with residents before work commences. Al also suggested showing a small group some examples of stairs with this product in similar shady areas to ours in parks in town. Since some people have already been over to look, a meeting has been scheduled for Thurs. Dec. 6th. for us to show Al an alternative product to the expanded metal.

After the main meeting Nov. 21st. Al met with some of the pickle ball group to discuss the issues with the surface of the court and planned remedial actions over the next few months.

7: Constitution Update: Discussion regarding whether only the membership should be asked for input re the constitution. Jim Menzies suggested that the executive read through the changes and that they be sent out to everyone in the first week of January via Pro-Isle, for people to review and respond.

8: Correspondence:

- a) Letter from City re Spyglass Lookout: Kevin will forward to Jason Metz at the Firehall for their information. He will also write to the City to thank them for the information.
- b) E-mail received from Ken Bailey who suggested in view of Terry Gordon's health (& no longer taking on clients) and Keith retired, that Protection Island will need a qualified septic technician in the very near future to service our needs and inquired if PINA could facilitate someone being trained. Discussion ensued and Doug Naylor mentioned that the Lions is currently exploring options for assisting someone to take over this task.
- c) Ken Bailey expressed concerns about the sometimes crowded parking at the circle. It was agreed there is not much PINA can do other than monitor abusers storing vehicles. As with moorage at Mud Bay it's first come first served and rafting is sometimes necessary, if the circle is full just park on the road.

9: New Business

- a) Gallows Point Dock: Discussion regarding an engineer's report commissioned by the City 2 years ago, which advises that the pier and the concrete ramp are overdue for significant repairs or rebuild. PINA will contact the City and ask for a hard timetable for getting it fixed.

10: Any Other Business:

- a) Blog/website: Francois would like to put his blog on our community website Jim MacQuarrie to discuss this with Francois.
- b) Logs on causeway: At the recent Lions meeting, it was mentioned that people tying up logs close to the causeway blocks access for kayakers during high tide. Islanders are reminded not to tie logs near docks, ramps or access points, if you're harvesting logs which is illegal.
